Introduction

By letter order dated January 6, 2025, Algonquin Gas Transmission, LLC ("Algonquin") was granted approval by the Federal Energy Regulatory Commission ("FERC" or the "Commission") to utilize the Commission's Pre-Filing Review Process for the proposed Cape Cod Canal Bridge Relocation Project ("Project"). The Project has been assigned Docket No. PF25-4-000.

This Monthly Progress Report provides a brief summary of significant Project activities or changes in Project information that have occurred from April 1 to April 30, 2025. Activities and milestones covered in this report associated with the FERC Pre-filing Review Process, landowner survey permission, field surveys, agency and stakeholder outreach are also provided below.

Landowner Contacts

To date, Algonquin has been granted survey permission on 97.62% (by tracts) of the proposed Project right-of-way tracts for which Algonquin needs survey authorization. Further, Algonquin has obtained survey permission for all four proposed M&R Station Sites in the Town of Bourne, Barnstable County, and survey permissions have been requested from affected and abutting landowners. On April 23rd, 2025, Algonquin attended FERC's Scoping Meeting Open House in Bourne, MA. The ROW team spoke to several impacted and abutting landowners to the project and followed up with them in the days after to resolve any concerns that were raised at FERC's meeting. Algonquin continues contacting landowners as needed to advise them of ongoing survey activities for the Project. Algonquin did not receive any landowner hotline calls in the month of April, so no exhibit will be included in this month's update.

Field Surveys

Civil Survey: Civil survey is 80% complete

Environmental Field Surveys

- **Biological Surveys:** Ongoing wetland and waterbody surveys were completed in April for updated Project areas, as weather conditions allow. Habitat assessments are preliminarily planned for June 2025.
- Cultural Surveys: Cultural resource surveys were conducted in April for updated Project areas and will continue in May.

Routing/Facilities Update

During this period, all preliminary plot plans for the four M&R Stations were completed. Audubon continues working on the 3D model for the four M&R Stations. The core bores at Bourne M&R Station were completed following the completion of Phase I archaeological surveys in April.

Additionally, Algonquin finalized the revised crossing method under the Sagamore Bridge, progressed the design of the G-31 launcher site and continued to evaluate routing options inside the Eversource easement wherever it is appropriate for both proposed pipelines G-31 and G-32.

Stakeholder Activities

Algonquin continues to engage stakeholders, including landowners, government agencies and community leaders to provide updates regarding the project. The focus for stakeholder engagement this reporting period was to continue to update external stakeholders.

FERC Scoping Meeting

The FERC Scoping Meeting announcement was communicated to stakeholders, including landowners, government officials, federal and state agencies by FERC. The scoping meeting occurred April 23, 2025.
